n 2012, we reached more than 10,000 women, men and children through our emergency shelter, hotline, legal advocacy, outreach and counseling programs.



The event raised more than \$20,000—enough to provide 300 nights of safe shelter for survivors in crisis.

## Counseling: The Healing Process for Kids



t Harbor House, we implemented the Helping At Risk Kids (HARK) Program last year thanks to the **Orlando Sentinel Family Fund**, and it has made a tremendous impact on the quality of services we offer.

HARK is an intervention and prevention program designed to empower children ages 4-17 from

abusive homes and consists of a 12-week course built upon nationally-recognized curriculum. Children are separated into age-appropriate groups and led through weekly classes where they participate in activities designed to educate them about domestic abuse and assist them in understanding and dealing with their emotions. Heavy emphasis is placed on breaking the cycle of violence by teaching anger management, non-violent conflict resolution and respect for others.

Individual counseling is also provided by a trained child advocate to develop a plan that is workable and therapeutic.

The HARK program is a top priority for us given the Florida Fatality Review Commission's 2010 finding that the most significant gap in services in child welfare is trauma-informed counseling for children who have witnessed domestic abuse.

Overall, 90% of children completed a comprehensive assessment, 75% of children had an individualized safety plan created and 80% of participants demonstrated an understanding of how to handle conflict non-violently.

We are thrilled with our first year of results and look forward to continued success in the coming year. With your support, we can expand our services for children who have experienced domestic abuse. HH

# Program Spotlight: Legal Advocacy

The Harbor House Legal Advocacy Program helps an average of 450 survivors per month who file for injunctions for protection against domestic violence, dating violence, sexual violence and stalking.

Harbor House is one of the few Legal Advocacy Programs in the nation that have a permanent office in the county courthouse. In fact, when the Clerk of Courts office closes, Harbor House advocates are deputized to complete emergency after-hours injunctions. This unique service allows 24-hour, 365-day-a-year access to injunctive relief.

We also offer a weekly court preparation class to help survivors prepare for the injunction hearing as well as a DV 101 class, which is presented in conjunction with the State Attorney's Office, for survivors whose abusers are facing criminal charges. A Harbor House advocate also accompanies all survivors to their injunction hearings so survivors never have to face their abusers in the courtroom alone.

Two of our most recent accomplishments are the development of a Pro Bono Attorney Program and our partnership with the Florida Agricultural and Mechanical University (FAMU) College of Law.

The Pro Bono Attorney Program helps survivors in need of legal representation on a pro bono basis in injunction cases. On average, we help secure eight to 10 pro bono representations per month. Assuming 10 hours of attorney time per injunction case, our Program saves survivors and our legal system approximately \$180,000 in attorney fees annually.

Attorneys also provide 30-minute consultations on a variety of legal matters including dissolution of marriage, child custody, immigration, criminal law and the landlord/tenant act.

Harbor House recently partnered with FAMU's College of Law to develop a clinical program through which law students learn about injunction court and also provide a valuable service by assisting survivors in the injunction process. The program will begin with the Fall 2013 semester. Harbor House's Court Services Manager, a licensed Florida attorney, will teach a class on domestic violence law at the school and will also provide on-site supervision of the FAMU law students.

With your support we will continue to develop cutting-edge initiatives. HH

This past February, Mayor Teresa Jacobs reconvened the Domestic Violence Commission following a five-year hiatus to address the growing problem of intimate partner violence and its devastating impact on families across Central Florida.

Harbor House has been an integral part of the Commission's efforts to both identify problems and more importantly,

recommend realistic solutions that can be implemented by the participating agencies, which include law enforcement leaders, corrections, mental health specialists, judicial experts and the state attorney's office.

In May, the Commission formally recommended several key changes to current processes to ensure a comprehensive approach to address survivors needs earlier in and throughout the judicial process. "We are proactively offering solutions for our comunity to end domestic abuse."

These changes require increased advocacy and support by Harbor House. As a result, we have proposed specific plans to provide this increased support, and we are

currently working with Orange County to determine how to fund the increased demand on our resources.

In addition, the Commission recommended increased training for virtually every agency that touches the judicial process in criminal domestic violence cases. Again, Harbor House has offered a plan to provide innovative online training based on its R3 model in which those trained would receive CEUs. The online training is coupled with in-person training by Harbor House experts.

These are just two examples of how Harbor House is not only actively involved in the discussion about ending domestic abuse, we are proactively offering tangible solutions that our expertise can bring to fruition.
